We will act on these issues in August as planned. The entire minutes of the NATA Board of Directors Meetings and Conference Calls are on the SEATA List Serve for your review.

Congratulations to **Marisa Brunett** on being elected SEATA Vice-President. I am confident that Marisa will continue to build on the progress that **Kelli Sabiston** initiated in this office. We also want to thank **Bud Cooper**, **Elijah Fletcher**, and **Bill Welsh** who made themselves available as candidates in this election. Regarding elections, the nomination process has now closed and you will be receiving a ballot shortly after September 15. You have a very important responsibility in choosing your District Director, President, and Treasurer for District IX in this election. Additionally, you will be asked to vote on some proposed changes in the SEATA By-Laws. Please do your part by submitting your completed ballot as per the instructions provided

I urge you to actively solicit membership in the NATA and SEATA among the allied health professionals and physicians with which you work. COMMITTEE REPORTS

College/University Athletic Trainers' Committee

Chair Courson called the meeting to order at 8:05am. He welcomed new committee members Rod Walters (D3) and Mark Pietrock (D10) to the group.

Courson congratulated committee members selected to receive awards this year. Walters will be inducted into the NATA Hall of Fame; Babich and Courson will receive the Most Distinguished Athletic Trainer Award; and McDonald was recently named to the ALATA Hall of Fame

CUATC Recognition Program

McDonald reported on the CUATC recognition program. Eleven college/university ATCs will be honored this year at the CUATC Session. Immediately following the session will be a luncheon to honor the winners, hosted by the Center for Drug Free Sport. President Kimmel, Eve Becker-Doyle, select board members and NCAA President Myles Brand will attend. Winners will have their photos taken for possible publication in the NATA News and Convention Daily News.

McDonald reported that the number nominations received was decent for the program's inaugural year. To get more nominations for 2006, the program will be promoted more heavily in the coming year. A dedicated e-mail will be sent to all college/university members in the fall. A reminder will be included in the NATA e-Blast in January. The program will also be mentioned in CUATC updates in the NATA News. The nomination form will remain online all year, but the 2006 season will close March 1, 2006.

The Over and Above award will now be known as the Above and Beyond award.

CUATC Session

Hanley reported that everything is in place for another successful CUATC Educational Session at the meeting. Myles Brand, NCAA President, will speak for approximately 20 minutes, followed by a question and answer session. The committee discussed several topics that might provide potential questions for Dr. Brand.

2006 Session

Thompson will coordinate the session for 2006. The committee discussed several ideas for topics for next year, including:

Mental health
Clinical depression
Alternative therapies
Drugs and alcohol
Risky behaviors
Eating disorders
ADHD
Suicide

Discussions could include ways to identify community resources to help with these issues.

Thompson asked for the committee's help in identifying speakers for the program. Members should send names to Thompson.

NATA only funds two non-ATC speakers per session. Klossner stated that the NCAA might be able to help fund an additional speaker for the CUATC Session.

Operational Standards

Toth has agreed to oversee this program, which will develop white papers on different topics of interest to the college/university athletic trainer to standardize practices. The initial topics (and potential authors) include:

Pharmacology, Robert Nickell HIPAA and FERPA, Keith Webster Administration and Facility Design, Mike Goforth Physician Services, Jeff Monroe Drug Testing, Frank Mer/Cindy Thomas/Rod Williams Radiology, Mike Dillon

Other potential topics for future white papers are infection control, hydration, facility design and beverage operations.

Each document will be approximately 3-5 pages and will include a statement that says these guidelines must also adhere to state and institutional policies. Toth will reference NCAA materials to ensure the new information doesn't conflict with their published information.

Materials should be completed by October 1. The committee will review the documents at the January meeting.

Education Degree Task Force

Courson reported that the Degree Task Force recently surveyed curriculum directors to determine _____. The group is currently developing an employer survey to see if a new program would make a difference in hiring practices. They are also trying to better sync

masters and graduate programs.

By 2014 there would have to be a listed degree in athletic training. A master's degree will not be a requirement.

Uniform Terminology Project

Thompson is representing the CUATC on this task force. He explained the group's purpose is to ensure that correct and consistent terms are used across the board. The group is meeting on Wednesday and Thompson will update the committee following that meeting.

Spearing in Football

The NCAA made the rule change proposed by the Spearing Task Force. The next step is to increase awareness through an educational campaign.

Poster Development: The poster is almost complete. It will be sent to all NCAA member associations. The poster will not have the NATA's name on it.

Since the poster will not be distributed to non-NCAA schools, it was suggested that the committee draft a letter on NATA letterhead telling community college/NAIA/NJCAA they can change the logo and pay to have individual posters printed for their member schools. It was decided that it would be better for this letter to come from NCAA.

Video Development: Jerry Punch has agreed to do the narration on the spearing educational video. Next an active college coach will need to be asked to appear in the video. The subcommittee is currently working on a script and funding sources.

PowerPoint: It was decided that a PowerPoint presentation should be created to educate officials about the new rule. The PPT can be offered on the NATA and NCAA Web sites for members to download.

Courson showed the committee a sample presentation that can be modified for use in different schools. Weir suggested adding a video of a defensive player being speared to illustrate that it's not just offensive players being injured. The group also discussed the possibility of filming Courson giving the presentation so that the tape can be used as an educational aid.

Educational Paper: Julian Bailes has volunteered to develop a 2-3 page educational paper on spearing.

Media Awareness: Courson spoke with Jerry Punch about doing a story on spearing and the rule change. June and/or July would be good

months to publicize the new rule. ESPN, CSTV, Fox Sports and PrimeTime Live may be interested in doing stories on the issue.

Jon Heck and Dr. Torg were suggested as potential speakers for next year's AFCA meeting.

NCAA ISS Update

Dick distributed sample reports from the Injury Surveillance Study. He reminded the committee that the NCAA is hosting a reception Wednesday night.

ISS training is ongoing this week at the NCAA office.

STATE REPORTS

Athletic Trainers' Association of Florida

"Governor Bush Veto's Florida's ATC bill".

This legislative session ATAF worked very closely with our lobbyist, Jon Johnson, ATAF members and legislators to "clean up" antiquated language that remains in the bill re: ATC requirements (i.e. the 800 hours required)....etc. to update where our profession has gone to since the educational reform, as well as trying to remove the "first aid requirement" and the "for compensation" language. compensation" language was to make sure that the health and safety of the public wasn't being put at risk if an unqualified person was performing athletic training services but as a "volunteer". Meaning, that since they were "volunteering" they could not be prosecuted for practicing athletic training. And that final change was to get in line with the changes that the Department of Education made in September 2004 re: the addition of a category for schools to hire a licensed athletic trainer if they so choose without a teaching certificate.

The bill's (House Bill 1061 sponsored by Representative Kreegel and Senate Bill 2268 sponsored by Senator Fasano) passed both the House and the Senate without any opposition; however was vetoed by Governor Bush (See VETO letter below) at the end of the legislative session.

We must ALL start to work together in each of our respected area's visiting with our legislators, continuing to educate our public, support our ATAF PAC and continue to move forward to help get this changes made in the next legislative session. Our Governmental Affairs committee and our Executive Board will be getting some "grass roots" information together for our membership to make even more of an impact for the next legislative session.

Past- President Brunett, along with Sue Foster the Executive Director for the Department of Health's Board of Athletic Training will be attending the BOC regulatory summit July 22-24th.

Dear Secretary Hood:

By the authority vested in me as Governor of Florida, under the provisions of Article III, Section 8, of the Constitution of Florida, I do hereby withhold my approval of and transmit to you with my objections, Senate Bill 2268, enacted during the 37th Session of the Legislature of Florida convened under the Constitution of 1968, during the Regular Session of 2005, and entitled:

An act relating to athletic trainers . . .

Senate Bill 2268 revises a number of provisions relating to athletic trainers, primarily revising the educational requirements required for licensure.

I am generally concerned with the growing use of state licensure to create modern guilds and protect market interests of select groups. Proposals to expand state licensure of a profession should meet the same criteria already in place in statute for the creation of new professional regulation, specifically:

- Statutory changes should prevent or limit the potential for a substantial risk of harm to the public.
- The skill the profession requires is specialized and readily measurable.

In applying these standards, I have the following objections to this bill.

First, there is no evidence of any pending risk to the public under the current regulations.

Second, "athletic training" is so broadly defined in the bill that it may capture a number of activities regularly performed by parents and volunteers, such as taping the finger of a five-year old child at a rocket football game. The state ought to encourage, rather than discourage, volunteerism at athletic events. This bill subjects volunteers to the fear of criminal prosecution.

Third, this provision attempts to further the continuing and troubling trend of criminalizing activities that are not inherently harmful or wrong. State licensure should only be required to protect the public, and must not be used to protect members of a profession from the supposed indignity of seeing volunteers perform tasks associated with that profession without compensation.

For the reasons provided above, I am withholding my approval of Senate Bill 2268, and do hereby veto the same.
